

# **Privacy Policy**

We at von Gegerfelt Photonics GmbH are well aware, that you receive a lot of e-mails related to the new <u>General Data Protection Regulation</u> (GDPR). This EU data protection legislation requires us to provide you with more information about how we process your personal data, why we may need it and of course your rights as a customer. This privacy policy is there to help you along the way.

#### General

The operator of this website and responsible body for the purposes of data protection during your visit to and also the data that you leave behind on our website www.vgphotonics.eu is von Gegerfelt Photonics GmbH. We may need to adjust this policy from time to time by updating this page, which may be due to changes to our site or changes to cookies. We are entitled to change the content of the policy and the list of cookies at any time and without notice, as part of the development of our website and the implementation of new legal requirements or new technologies, or to improve our service to you. We recommend you to visit this page to read this Privacy Policy from time to time, to ensure that you are happy with any changes and updates.

We have not changed the way we use your individual data information, but we have become more aware to be even more sensitive about handling it with care.

#### **Cookies**

We may use cookies to enable all functionalities for best performance during your visit, to improve our services by giving us some insight into how the website is being used. If you choose not to accept cookies, you may risk some parts of the site working slightly worse or not at all.

A cookie is a small text file containing information, which asks permission to be placed on your computer's hard drive. Cookies are usually used to improve the website of the visitor. There are two types:

- Durable cookies are a file stored on the visitor's computer, which remains until the end of the term. The file is used for example to make it easier for visitors to use the site based on their wishes and interests. They disappear if the visitor chooses to clear cookies from the browser.
